- **Purpose:** Gather public comments and community input regarding data centers, meet with residents in all incorporated cities and unincorporated areas of Boyle County, and document community priorities and concerns to inform the draft Data Center Ordinance to be prepared in 2027 prior to the expiration of the moratorium.
 - **Public Meeting Frequency:** Except for September, two public meetings per month are held on the **First Tuesday** and **Third Wednesday** of each month from **5:30 p.m. to 7:30 p.m. EST** (4:30 p.m. to 6:30 p.m. CST).
 - **Target Data Center Ordinance Adoption:** April – June 2027
